

INSURANCE CLAIMS EXPERIENCE TO DATE:
DFC AND ITS PREDECESSOR AGENCIES

The United States International Development Finance Corporation (DFC) provides political risk insurance and project financing in support of eligible private-sector investments in developing nations, and countries in transition from nonmarket to market economies. DFC, the successor in interest to the Overseas Private Investment Corporation (OPIC) under the terms of the Better Utilization of Investments Leading to Development Act of 2018, started operations as of December 20, 2019, upon enactment of the Further Consolidated Appropriations Act, 2020 (Public Law 116-94). As noted in greater detail, below, OPIC programs were administered by the Agency for International Development (USAID) before OPIC initiated operations in 1971.

Since 1971, OPIC and DFC have made 306 insurance claim settlements totaling \$1.043.5 billion. These settlements have been structured either as cash settlements to investors (\$687.5 million) or as OPIC guaranties of host government obligations or other similar arrangements (\$356 million). In accordance with those arrangements, DFC's predecessor agencies have paid \$130 million in addition to the cash settlements described above for a total of \$817.5 million in cash payments to date.

DFC cash recoveries on claims total \$782.1 million (without regard to reinsurance reimbursements). Additional recoveries in the form of OPIC guaranteed obligations (\$226.0 million) bring DFC's total recoveries to \$1.008 billion, or 97% (includes interest) of all claim settlements. Additional recoveries are anticipated.

From 1966 to 1970, USAID paid \$3.5 million to settle eight claims. In addition, USAID denied eight claims, one of which was submitted to arbitration by the investor.

OPIIC denied [thirty](#) claims under the insurance program, of which [fifteen](#) have been submitted to arbitration by the investors. As of September 30, 2022, there were five pending claims under review by DFC.
